## **Terms & Conditions of Participation**

- Terms, conditions and limitations of liability under which
  the tours operate are detailed below and the payment of the
  tour deposit or tour price represents acceptance by the
  purchaser of the following:
- 2. Edu-Ventures LLC is the principal and is responsible to participants in making arrangements for all services included in the program. Each participant (and the parents/guardians for participants under 21) however, by signing the application, releases Edu-Ventures LLC from any injury, loss, damage, cost, accident, irregularity, or expense arising out of the performance or operation of an Edu-Ventures LLC program except for any such claim arising out of the negligence or fault of the directors, officers, or employees of Edu-Ventures LLC in the scope of their employment.
- 3. Edu-Ventures LLC cannot be responsible for events beyond its control such as, without limitation, acts of God, strikes, or government restrictions, or for acts or omissions of persons not controlled by it, such as, without limitation, airlines, bus companies, car companies, cruise lines, railways and hotels. I agree to release Edu-Ventures LLC, its agents and employees, and the local program organizers/advisors from all claims arising out of such events. acts or omissions.
- 4. These tours involve travel in foreign countries(s) and Edu-Ventures LLC (herein after referred to as the Edu-Ventures LLC) reserves the right to alter itineraries or accommodation as necessitated by weather, road and other operational conditions prevailing at the time each tour takes place as well as for the safety and health of the participants. I understand that these changes are not grounds for cancelation without penalty.
- 5. Any personal expenses incurred by a passenger as a result of any delay, alteration or curtailment of any tour, whether caused by mechanical defect, flooding, or any other cause are the responsibility of the passenger. In the case of breakdown or other unforeseen circumstances, the Edu-Ventures LLC reserves the right to substitute vehicles other than specified to ensure operation of the tour. The Edu-Ventures LLC cannot be held responsible for any late return that causes passengers to miss ongoing connections.
- 6.   comply with such rules may result in my termination as a
  participant with no guarantee of any subsequent refund
  from Edu-ventures LLC. I understand the participants

- under the age of 21 are not permitted to possess or drink alcohol. I understand that participants are not permitted to have in their possession or to use any drugs. Drug possession or use is grounds for immediate dismissal and return home by first available transportation at my own or my parents' expense. I understand that Edu-Ventures LLC is not responsible for my well being when I am not participating in an Edu-Ventures supervised activity.
- 9. I agree to indemnify Edu-Ventures LLC, its agents and employees and hold them harmless for any liability or obligation I personally incur, or injury or damage to the person or property of others which I cause or contribute to while participating in an Edu-Ventures LLC program.
- 10. The passenger warrants to the Edu-Ventures LLC that he/she is reasonably healthy and/or fit to participate in the tour and indemnifies the Edu-Ventures LLC from all actions, claims and demands arising out of any want of health and fitness. The Edu-Ventures LLC accepts no liability for any losses incurred by the passenger in respect of any unused portion of the tour for additional expenses incurred for repatriation. The operation does not take any responsibility whatsoever for any injury, or any loss of any type, arising from any excursion not operated by the Edu-Ventures LLC, including scenic flights and river cruises.
- 11. Edu-Ventures LLC reserves the right without payment of compensation to decline to accept and/or to terminate any tour passenger's participation in the tour, whether before or after commencement of travel, if it may appear likely that a passenger's health, general deportment or conduct would impede the operation, safety or comfort of the tour to the detriment of other passengers.
- A deposit of \$600.00 per person is required to confirm your booking. Failure to pay the deposit within 7 days of confirmation advice may result in the cancellation of your booking. Full pre-payment for all tours is required 21 days before departure.
- 13. The tour prices in this brochure are correct at the time of printing and published in good faith. They are however subject to increase without notice because of increases in accommodation, fuel, transport fares or any other tour component prices.
- 14. I understand that if I wish to cancel my reservation in an Edu-ventures LLC program, I must do so in writing. Upon cancellation, I will be entitled to a refund minus the costs incurred by Edu-Ventures LLC due to the cancellation and a cancellation fee.
- 15. There will be no refunds for services, meals, sightseeing, accommodations, or transportation (including airfare) missed or not used by participants for any reason, once the program has begun.
